	60 College Credits OR Associate's Degree AND
	KEY AREA REQUIREMENTS Additional 30 College Credits in any of the four Key Areas: <i>Nutrition, Operations, Administration, Communications/Marketing (see table on page 4)</i> OR Work experience in coordinating, managing or supervising various aspects of child nutrition programs may be substituted for 30 college credits (1 year of work experience equals 10 college credits) AND
